## SECTION 4: FIRST AID MEASURES

### 4.1 Description of first aid measures:

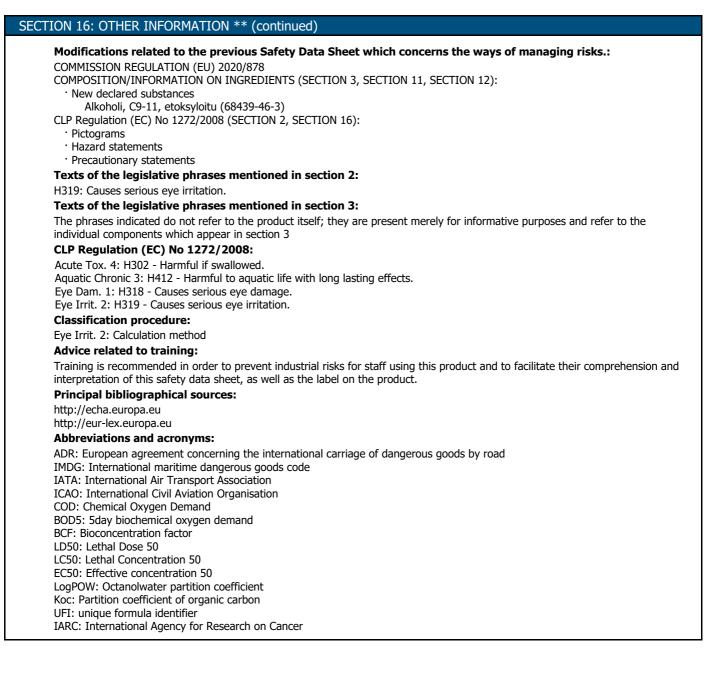
